

#### **INGREDIENTS**

2-3 bunches fresh broccoli cut into bite size pieces

4 strips bacon, cooked and crumbled

½ medium red onion, cut into rings

Salt and pepper

Paprika, optional

1 can 7-Up

#### **DIRECTIONS**

Add all ingredients to a crock pot. Cook on high for 8 hours. Throughout the day you can stir it as the meat will fall apart. Season to taste. You may need to add more seasoning. *Note: Serve* as taco or burrito meat or use as a great filling for enchiladas.

# **COMMUNITY PROFILE: COMMUNITY POOLS**

There's no better way to spend a summer day than swimming in a sparkling pool of cool water. Pools bring communities together throughout the summer months in Montana by providing swimming lessons, lifeguard training, swim teams, exercise class, birthday parties, and other summer fun!

The Chinook City Pool is a must-stop along the Hi-Line. It features diving boards, a pool slide, a wading pool, and a city park next door with benches to enjoy a picnic after swimming.

Hobson is also home to a community pool. Throughout the summer, youth, young, and old, can be seen going down the slide, jumping off the diving board, and playing with friends.

North Star Schools manages the only public indoor pool in our cooperative serving area. The pool was originally part of the Hingham School District and is located right on Highway 2.

The City of Big Timber manages the Ramsey Family Pool. Community members can splash in the pool and then play a game of baseball, horseshoes, use the playground, enjoy a picnic, and the many other fun activities at the Big Timber Town Park where the pool is located.

The Chester Memorial Pool has been a mainstay during the summer for the area community. The Hi-Line Pool and Recreation Foundation constructed a new swimming pool and pool house in 2008. The pool was built with donated funds and turned over to the Town of Chester for operations.

The Harlem City Pool has been a pillar for the community for generations. In 2022, a generous sponsor provided free swimming passes for all swimmers for the first 2 months of the summer. The Harlem pool has a diving board for those swimmers brave enough to take the plunge.

The Big Sandy City Pool has been serving the community for decades. The pool attracts visitors from outside of the community with young children with its splash pad and sprinkler park. The pool also has two small water slides.

Next to Geraldine Schools, you will find the Geraldine Community Pool. It is complete with a slide in the shallow end, a diving board in the deep end, and a basketball hoop for everyone to use. The outdoor area has a covered spot for parents to get out of the sun for a bit while their kids enjoy playing in the pool.

Next to the park in Denton, you will find the swimming pool. Throughout the summer, you will find the area youth going down the slide, playing basketball, and enjoying time spent outside with friends.

Fort Benton also offers an outdoor swimming pool with an outdoor recreation area next to it that accommodates basketball, horseshoes, and tennis. If you look out from on top of the diving board, you might be able to catch a glimpse of the mighty Missouri River.

The Malta City Pool features concessions onsite to keep you hydrated and snacks for energy. The pool also has a diving board and a covered area next to the pool to enjoy a snack and get out of the sun for a bit.

The park in Stanford is home to the community pool, a playground and park benches. A diving board and slide are big attractions in the summer for the area youth.

# **CEO MESSAGE**



The Board of Trustees would like to inform the Triangle membership that they approved adding additional exchanges into District 3 at the November board meeting. The change in districts is a direct reflection of the bylaws (Section 5.02, Trustee Districts) and the policy to review districts at least every six years. The Board of Trustees does its best to ensure that each district has about the same number of members per district. This necessitated the need to move Hingham, Gildford and Kremlin from District 4 to District 3 and has closely equalized the number of members in each district. This

message serves as notice to all members of the redistricting. If you live and are a current member in Kremlin, Gildford or Hingham and would like to run for a Trustee position in the future, you will now have to run in the District 3 election instead of the District 4 election.

With the change in the district boundary, District 3 will gain the Kremlin, Gilford and Hingham exchanges (circled in red), the exchanges will go from green to dark blue on the next map once issued. Please check our website for the latest information on news about the cooperative and for the new district map.



# CALL MT 811 BEFORE YOU DIG....IT IS THE LAW

Whether you are an excavator, farmer, or homeowner, if you are digging or placing any object in the ground, you are required to get marks indicating the location of the underground utilities. The person doing the digging is the person who must call 811 to request the locate.

## HERE IS THE INFORMATION YOU WILL NEED WHEN **YOU CALL 811:**

- Your name, phone number, company name (if applicable) and mailing address.
- An alternate contact person in case the utility companies have questions and cannot reach you.
- What type of work is being done.
- Who the work is being done for.
- The county and city the work is taking place in.
- The address or the street where the work is taking place.
- The nearest cross street or road.
- The distance and direction to the worksite from that intersection. (Directions are required if no address is provided.)

- Specific instructions to where the work is taking place.
- Please use white or pink paint or white or pink flags to outline the area you are digging in.
- Township, range, section, and quarter section of the worksite and GPS Coordinate of the center point of the digging area.

This information helps the 811 customer service representative determine which utility companies need to be notified of your excavation plans. This process makes sure all the utilities are located and those facility owners who do not have lines are not needlessly notified.



# TRIANGLE COMMUNICATIONS USE OF **CUSTOMER PROPRIETRARY NETWORK INFORMATIONS** • MAY 1, 2023

Triangle Telephone Cooperative Association, doing business as Triangle Communications, respects your privacy and observes the privacy rules established by the Federal Communications Commission (FCC) and the Montana Public Service Commission. Under federal law. you have the right to confidentiality of information regarding the telecommunications services to which you subscribe, and Triangle Communications (Triangle) has the duty to protect that confidentiality. This confidential information includes specific telecommunications services you purchase, the number of services purchased, who your provider is for a service, call detail records and charges related to services purchased. This information is referred to as Customer Proprietary Network Information (CPNI).

Triangle does not sell your account information or provide details of your telephone calls to other parties, unless required by law enforcement. Triangle is authorized by the FCC to

market, without approval, services to our customers within the categories of telecommunications service to which those customers subscribe. Specifically, those services are local, long distance and wireless telephone service. Triangle provides long distance and mobile telephone services through its subsidiary, Triangle Communication System, Incorporated. From time to time, we may market additional features to customers who subscribe to one or more of the service categories and do so through our subsidiary's.

Federal regulations require that telecommunications customers be given the opportunity to decline if the provider plans to use CPNI to market communications-related services outside of those to which customers subscribe. Communications-related services include Internet in addition to local, long distance and wireless. Declining to receive these offers will not affect any of your current services. If you decide to opt-out of having your CPNI accessed or used for marketing communications-related services outside of those to which you subscribe, please let us know within 30 days by e-mail:

Send an e-mail message to CPNI@ itsTriangle.net; we will need your name, telephone number(s), and the effective opt-out date. This information will be kept on file and your CPNI will not be used for marketing any communications-related services outside of those to which you subscribe unless you expressly revoke your optout notification by the method listed above. Please be aware that if we don't hear from you after 30 days has passed, we will presume that you have not opted-out but know that you can notify us at any time if you change your mind.
